Computer Allowance	Active	One-time payment of \$1000 upon scholarship activation. Students who are approved for an extension at a new degree level are not eligible to receive a 2 <sup>nd</sup> computer allowance.

Extensions to a New Degree Level: <ul style="list-style-type: none"> <li>BA to MA: 24 months</li> <li>MA to PHD: 60 months</li> <li>MA to Specialized: 36 months</li> </ul>	Active	<p>CBIE is authorized to extend tuition and insurance benefits to students upon receipt of a 2015-2016 extension approval decree from the Ministry. Monthly Living Allowance for Students who have Date Discrepancies	Active	As per the agreed upon policy between the Scholarships Department and CBIE, in such cases where there is a discrepancy between a student's Ministry scholarship end date and actual scholarship end date, due to such factors as adjusted start dates, freeze periods, etc., CBIE is authorized to continue scholarship benefits according to the student's actual scholarship dates, which includes issuance of financial support letters based on actual scholarship dates and issuance of MLA at the same time that all other eligible students receive the quarterly MLA.
Monthly Living Allowance Adjustments due to New Baby/New Spouse	Active	CBIE is authorized to adjust the MLA rate upon receipt of a decree from the Ministry.
