Instructions and Important Reminders:

As requested by the Ministry of Education, nominated students on Tafweedat 25, 26, 27/2014 and 1/2015 who are currently in the US or Canada are requested to completed and submit this form with the below mentioned supporting documents to nominee.us@cbie.ca (for students currently residing in the United States), or to nominee.ca@cbie.ca (for students currently residing in Canada) as soon as possible and no later than Friday, July 14, 2017. CBIE will then promptly forward the required information to the Ministry of Education for their review. Please also note the following:

- CBIE has not received the budget or the authorization to activate scholarship benefits for any students on the above-mentioned Nominee Tafweedat Lists. This means we are unable to issue any Financial Support Letters, or to release any Monthly Living Allowance payments, or to activate health insurance coverage, at this time. Furthermore, it is unknown if or when scholarship coverage may go into effect, and whether said coverage would be retroactive or not. We will update students as soon as we receive further instructions from the Ministry.
- Students on Nominee Tafweedat 25, 26, 27/2014 and 1/2015 who are in Libya are advised to contact the Ministry directly, as CBIE is currently only able to respond to inquiries from students who are already in the US/Canada.
