

LNASP FORM: REQUEST FOR REIMBURSEMENT- THESIS

Policy: In accordance with Ministry decree dated June 9, 2020, please note the following:

- The files for students whose **scholarship period ended before 2019** are automatically closed, and students are therefore not eligible to request any further benefits. This means that you will be required to make your own travel arrangements back to Libya at your own expense, as no further payments or reimbursements can be made on your behalf.
- Students whose scholarship ended in 2019 have a 3 month period to close your file and depart North America. (Note: Due to current airport closures, the 3 month deadline will start from the date airports in Libya re-open, and travel must occur during that 3-month window.) For any students who do not request to close within the designated 3-month window, your files will automatically be closed and final reports will be sent to the Ministry.
- Students whose scholarship ends in 2020 and forward will have a 6 month period to close your file and depart North America. No requests for thesis, final ticket, baggage allowance, etc. can be processed more than 6 months after your scholarship end date. Travel must occur within the 6 month period, meaning tickets cannot be booked for travel dates that exceed 6 months. For any students who do not request to close within the designated 6-month window, your files will automatically be closed and final reports will be sent to the Ministry.

For Libyan students in the United States, please note that the declared value on the Customs and/or FedEx Form should be listed as: "no value," otherwise delivery cannot be confirmed. If you list the value as an amount, such as \$150, \$300, etc., a fee will be charged to CBIE for delivery. The fee typically ranges from \$20 - \$50. Failure to fill out the form properly will result in that fee being deducted from your thesis reimbursement.
