Professor Joseph Wong is Vice-President, International, University of Toronto, where he is also the Roz and Ralph Halbert Professor of Innovation at the Munk School of Global Affairs, and Professor of Political Science in the Faculty of Arts and Science. He held the Canada Research Chair in Health, Democracy, and Development for two terms from 2006 to 2016. He is the author of many academic articles and several books, including *Healthy Democracies: Welfare Politics in Taiwan and South Korea* and *Betting on Biotech: Innovation and the Limits of Asia's Developmental State*, both published by Cornell University Press.

Inspired by the Sustainable Development Goals, in collaboration with the Mastercard Center for Inclusive Growth, Professor Wong founded the Reach Alliance, a model for student-led, faculty-mentored, multidisciplinary research dedicated to investigating the pathways to success for innovative programs that are reaching the world's most marginalized populations: <u>http://reachalliance.org/what-is-reach</u>. He is a graduate of McGill University and the University of Wisconsin-Madison.

Mr. Fried is a Senior Advisor with Bennett Jones, LLP in Ottawa, the Albright Stonebridge Group in Washington, DC, Senior Associate to the Center for Strategic and International Studies also in Washington, DC, and Advisor to Llewellyn Consulting in London, UK.

Prior to his retirement from the Government of Canada in August, 2020, he was Coordinator for International Economic Relations, with a mandate encompassing responses to the CoVid pandemic, and Canada-Asia and other international trade and economic matters. From 2017 to early 2020, he was the Personal Representative of Prime Minister Justin Trudeau for the G20.

Previously, he served as Canada's Ambassador and Permanent Representative to the WTO 2012-2017, where he played a key role as Chair of the WTO's General Council in 2014 and Chair of the Dispute Settlement Body in 2013. Formerly Canada's Ambassador to Japan; Executive Director for Canada, Ireland and the Caribbean at the IMF; Senior Foreign Policy Advisor to the Prime Minister; Senior Assistant Deputy Minister for the Department of Finance and Canada's G7 and G20 Finance Deputy. Mr. Fried has also served as Associate Deputy Minister; Assistant Deputy Minister for Trade, Economic and Environmental Policy; Chief Negotiator on China's WTO accession; chief counsel for NAFTA; and Counsellor for Congressional Affairs at the Canadian Embassy in Washington, DC.

Starting his professional life as Professor of International Law at the University of Toronto, Faculty of Law, Mr. Fried has been an adjunct professor at Georgetown University Law Center, the University of Ottawa, and the Norman Patterson School of International Affairs of Carleton University. He has published numerous articles and book chapters on international legal, trade and financial topics.



Lynette Ong Associate Professor, Asian Institute and Munk School of Global Affairs and Public Policy, University of Toronto Lynette H. Ong is a political scientist at the University of Toronto where she has served as director of China Initiatives at the Munk School of Global Affairs and Public Policy. She specializes in Chinese politics and economy. She is the author of *Prosper and Perish: Credit and Fiscal Systems in Rural China*, (Cornell University Press, 2012). Her publications have also appeared in *Foreign Affairs, Foreign Policy, Washington Post, Globe and Mail, South China Morning Post, East Asia Forum*, among others.

She has been a Visiting Fellow at Harvard University' Weatherhead Center for International Affairs, and was an An Wang Postdoctoral Fellow at Harvard's Fairbank Center for Chinese Studies. She has also held visiting fellowship at Peking University, Fudan University and Renmin University in China. She has delivered expert testimony at the US-China Economic and Security Review Commission, and Canada's House of Common Special Committee on Canada-China Relations.



Colin Robertson Vice President and Fellow, Canadian Global Affairs Institute A former Canadian diplomat, Colin Robertson is Vice President and Fellow at the Canadian Global Affairs Institute and hosts its regular Global Exchange podcast. He is an Executive Fellow at the University of Calgary's School of Public Policy and a Distinguished Senior Fellow at the Norman Paterson School of International Affairs at Carleton University and he teache3s at the Canadian Foreign Service Institute and Queen's University. An Honorary Captain (Royal Canadian Navy) he is also a member of the Defence Advisory Board. During his foreign service career, Colin served as first Head of the Canadian Embassy's Advocacy Secretariat in Washington, Consul General in Los Angeles, Consul in Hong Kong and in New York. A member of the teams that negotiated the Canada-US FTA and then the NAFTA, he is a member of the Deputy Minister of International Trade's Advisory Council. He writes on foreign affairs for the Globe and Mail and he is a frequent contributor to other media.

Mr. Rana Sarkar was appointed as Consul General of Canada in San Francisco | Silicon Valley in 2017, with accreditation for Northern California and Hawaii. He is also a member of Canada's NAFTA Advisory Council. Mr. Sarkar previously served as National Director for High Growth Markets at KPMG Canada, and co-chairman of the advisory board at the Munk School of Global Affairs at the University of Toronto. From 2009 - 2013, he was President and Chief Executive Officer of the Canada-India Business Council.

In 2005, Mr. Sarkar co-founded Content Partners, a global content agency (sold in 2009), and, in 2001, the advisory firm Rawlings Atlantic Limited. He began his career as a consultant at Roland Berger Strategy Consultants in London and Munich and helped establish Roland Berger in India. He also served as a visiting lecturer at the London School of Economics and the CASS Business School at the University of London.

He attended the London School of Economics, Queen's University at Kingston, Ontario, and the INSEAD Executive Program in France. He is a member of the advisory council of the Mowat Centre for Policy Innovation, Canada2020, and The Literary Review of Canada and a Distinguished Fellow at the Munk School of Global Affairs, University of Toronto. Mr. Sarkar is married to lawyer and author Reva Seth. They live in San Francisco with their three children and oversized labradoodle.
